- Excellent hydrodynamic properties and excellent hardness are required
- Slight discolorations and organic matter such as HMF, riboflavin, and taste/odor compounds need to be removed
- An excellent thermal regenerability is required
- An excellent in situ reactive regenerability is required

NORIT ROX 0.8 extruded activated carbon is produced by steam activation of wood charcoal, followed by a multi-step washing process for high purity. The renewable feedstock and manufacturing conditions have been optimized to yield a product that has well-developed micro-porosity and meso-porosity. Its superior hardness and porous structure make this extruded carbon particularly suited for in situ reactive regeneration and thermal reactivation.
